

INTERNAL RULES



1. Access

Access to the campsite and to use its services is reserved exclusively for those who have previously registered at the reception. The campsite management reserves the right of admission or permanence of any person who does not respect the internal rules and, in general, who does not respect the principles of civilized life as established in the Official Regulations and the FCC Indoor Camping Regime.

2. Registration

Park in the parking lot in front of reception (maximum 15 minutes).
Show the valid identity document of all members when checking-in.
At the time of registration, the holder must be of legal age and will be responsible for all acts and damages that he or his companions may cause. You must go on foot to choose the plot number and before settling in, it will be communicated at reception.
A deposit of 5 euros must be paid to acquire the key to the main gate.
Any modification of what has been declared will be communicated at reception immediately.

3. Essential

The **usual state** of permanence while the weather allows it will be full nudity.
In **no case** will it be allowed to appear publicly with garments classified as underwear or bathing suits.
It is totally forbidden to take photographs that involve outsiders.
Relax-Nat is a **FAMILY NATURIST CAMPSITE**, the client must demand of himself a particularly correct public behaviour, in terms of customs, education, morality, vigilance and control of children, use of alcohol or other stimulants.

4. Plots

Only one car is allowed to park per plot.
The maximum number of people per plot is 6 and the installation of more than one family or expedition in the same plot will not be allowed. In the case of having a second vehicle, it must be parked in the large parking lot paying the corresponding fee.
Occupancy with a car or other effects of a plot other than the one declared will automatically mean paying an additional plot.
The steps and interior paths of the campsite will be left free at all times.
The change of plot must be consulted in advance at reception.
Campers and their belongings will leave the campsite before 6:00 p.m., upon payment of the corresponding invoice. If they exceed that hour, they will pay an additional day.
The payment of the total amount of the stay will be paid the day before 8:00 p.m. or the same day of departure from 9:00 a.m. at the campsite reception.
The electrical disconnections, if applicable, will only be carried out before 18:00 in the afternoon.
No type of landscaping or modification is allowed on the plot.

5. Visits

Any person who enters the campsite for any fraction of the time must register before entering, paying the corresponding fees if the visit exceeds 60 minutes.
The minimum rate will be the payment of people, vehicle and pets if applicable, depending on the season.
The vehicle of any type of visit will be parked in the large parking lot as long as there is availability.
Visitors will have to leave the campsite before 7 p.m.

6. Payment

You can pay in cash or with any type of credit card except American Express.
We also accept ANCV (French "Chèque-Vacances").
No other type of check or Eurocheque will be accepted.

7. Vehicles

The maximum speed for all vehicles is 10km / h.
From 11pm to 7am it is forbidden to circulate with motorized vehicles or bicycles inside the campsite.
Any vehicle that enters the campsite after 11 p.m. will park directly in the large parking lot.
The parking lot cannot replace the parking of the vehicle on your plot.
No vehicle that is not subject to a fee is allowed to enter the campsite.
The sports or entertainment use of any motorized vehicle or not on the asphalt floors of the campsite is prohibited at any time.

8. Silence

Rigorous demand in respect of silence both day and night. From 10 p.m. to 7 a.m. these measures will be extreme.
During the day, the volume of electronic and digital devices is requested to be kept at a reasonable intensity. Understanding, solidarity and common sense are requested.

9. Pools

The state of full nudity is mandatory at all times and under any circumstance within the enclosure of the large pool, small pool and jacuzzi.
It is mandatory to shower before getting into any pool.
Children under 10 years old must be accompanied by an adult who assumes all responsibility.

General prohibitions

The use of inflatable mattresses and giant floats is prohibited. Only armbands, small floats and noodles are authorized.
Goggles, snorkels and diving ducks are not allowed in the pools. Only swimming goggles are authorized.
Playing ball both in and out of the water is prohibited.
It is totally forbidden to enter the pool with any glass object.
The entry of domestic animals is not allowed.
Running, pushing or disturbing the order of coexistence is not allowed.

Small pool:

It is for children up to 6 years maximum, accompanied by an adult.

Jacuzzi:

The use of hammocks is for all clients of the campsite. A civilized and respectful behaviour is requested in order to be able to enjoy all. You cannot leave the hammock occupied if you leave the jacuzzi zone.

Rigorous silence is required in this pool, as it is a relaxation area. Diving, jumping, splashing or screaming is strictly prohibited. If this happens, the camping staff may demand that the client leave the jacuzzi zone.

10. Electricity supply

The doors of electrical cabinets should always be locked for security reasons.

Electric cables must be grounded and properly insulated. Exterior splices are not allowed.

Each plot has only one 6A / 1320W electricity outlet.

11. Pets

It is not allowed to leave the animal alone and unattended.

Inside the campsite they must always be tied.

The entry of animals in the areas of swimming pools and sanitary blocks is prohibited.

The campsite has a pipi-can, the owner must immediately collect the excrement that they may produce. The campsite has bag dispensers for this purpose.

The dog owner must ensure that the dog does not bark or disturb other clients.

The owner is responsible for any damage or damage caused to people, objects or other animals.

We remind you that animals are not allowed in the Tonga, Nemo and Morea bungalows.

If the client brings a pet in a bungalow, they must always notify at the time of booking since we only have a few bungalows in particular where we allow pets.

In order to enter the campsite with a dangerous breed dog, it is mandatory to present at reception:

The potentially dangerous dog license.

Civil liability insurance with the minimum capital insured for damages to third parties.

Dog health record with all vaccinations up to date.

Dangerous breed dogs must always wear a muzzle in public spaces within the campsite.

List of Potentially Dangerous Dogs: Akita Inu, American Staffordshire Terrier, Doberman, Dogo Argentino, Fila Brasileiro, Pitt Bull Terrier, Rottweiler, Staffordshire Bull Terrier and Tosa Inu.

12. Wi-Fi

Throughout the campsite and bungalows, you can connect to our Wi-Fi connection. You can ask for your username and password at reception **upon payment**.

13. Barbecues

The use of barbecues will be authorized in the plots and bungalows as long as they are approved and a flame is not made that exceeds the height of the sides of the barbecue.

The use of firewood for this purpose is prohibited. Charcoal or gas will be used.

The use of barbecues is prohibited when the weather conditions are not suitable and when the ALFA Plan of the Generalitat de Catalunya notifies the Camping Management, which will be in charge of notifying clients.

The campsite has a common barbecue area, which can be used freely.

It is forbidden to make fire directly on the ground.

14. Trees and plants

It is forbidden to tie wire to trees, as well as to drive nails.

Ropes can be tied loosely and protecting trees or plants, please respect them.

15. Games and sports

In order to avoid inconvenience to other campers, these activities will be carried out in the areas designated for it.

After 9 p.m., any activity that could disturb the campers is prohibited.

The campsite has bicycle rental.

16. Activities

Any mass gathering (contests, celebrations, parties, social events, etc.) must be expressly authorized by the Camping Management.

17. Rubbish

The campsite does the selective collection of waste. Please, help us to respect the environment by using the containers intended for this purpose.

18. Waste water

It will be poured into the chemical toilet located in the area of the car wash. Please, keep the installation clean at the end of use.

19. Insurance and theft

All clients must have sufficient insurance.

The camping company is not responsible for theft or damage of any kind that campers may be victims.

The campsite has safety boxes (safes) where campers can deposit money and valuables by paying a small fee daily.

The campsite will not respond to damages that are not directly attributable to meteorological or natural phenomena.

Nor will it respond if the client's vehicle is damaged both inside the campsite and in the parking area.
